Pursuant to the recent regulatory amendments under the SEBI (Issue and Listing of Non-Convertible Securities) (Amendment) Regulations, 2024 and in accordance with the BSE Circular Notice No. 20240910-58 dated September 10, 2024, the prescribed record date is now revised to fifteen (15) days.

Accordingly, we hereby intimating revision in the record date for all outstanding Listed ISINs specified in **Annexure A**. Initially, as outlined in the relevant Term Sheet/Key Information Document, the record date was set as seven (7) days (excluding the date of intimation and record date) prior to the due date for payments or entitlements.

Further, please note that for Kotak Infrastructure Debt Fund Limited, we have earlier filed record date intimation on 05th October 2024 having acknowledgement number 7999639 for the month from November 2024 till March 2024 which will stand ratified and revised from the Month of November 2024 and onwards.
